1. Behind the scenes of the 2015 SFE CEFEC Conference

➤ The 28th SFE- CEFEC Conference in Olten was a success, with the organization done by the School of Social Work of the University of Applied Sciences and Art Northwestern Switzerland and the high performance of our last SFE CEFEC president Bernadette Wüthrich. The moderation of the event was a great job done by Bernadette and Stefan Adam and the venue was very well chosen for plenary sessions, workshops, panel discussions, breaks and gala dinner. There were about 130 participants from 12 countries and a lot of valuable academic presentations, meetings with practitioners from the social economic field.



➤ The winners of the 2015 SFE CEFEC Award were 2 organizations, one from Greece — KOISPE DIADROMES and one from Switzerland Oeko Service Ltd. from Zurich/Switzerland.









2. ACCES PLUS Project

➤ SFE CEFEC organized in the period **28 September – 6 October 2015**, within the "ACCES PLUS" project, **5 personal development seminars** in Suceava, Siret, Botoşani, Alba Iulia and Făgăraş. The main issues addressed in the seminars were: tests of self-awareness, improving communication skills and teamwork, interviews through role play.

➤ In the period 23-24 November 2015, SFE CEFEC organized the Regional Conference "ACCES PLUS CIS Centers —trustworthy partners for services of social inclusion on the labor market".

The Conference was organized Suceava and two of our members Jukka Lindberg (VATES Foundation Finland) and Tom Zuljevic Salamon (Die Querdenker Austria) made presentations about the Finish and the Austrian models for social inclusion on the labor market of the vulnerable groups.





In the period **26-27 November 2015**, Die Querdenker organized the **Regional Conference** "ACCES PLUS CIS Centers –trustworthy partners for services of social inclusion on the labor market" in Alba Iulia. The event had over 70 participants, representatives of the Ministry of Labor, General Directorate of Child Protection, NGOs and representatives of local media.
