about SFE CEFEC

Social Firms Europe CEFEC – is a Confederation of European Social Firms, Employment Initiatives and Social Co-operatives.

SFE CEFEC has been in existence for 27 years. Started as an informal network of pioneers in the field of work rehabilitation and employment for people with mental health problems, SFE CEFEC is now a Europe-wide organisation with representatives from more than 20 European countries, which focuses on the development of Social Firms. The members no longer represent the needs of only those with mental health problems but other types of disability and disadvantage as well. It is well acknowledged however that those with mental health problems are probably the furthest removed from the labour market for which the Social Firm approach is particularly suited.

The **SFE CEFEC Annual Conference** – a crucial activity for the organisation – takes place in a different European city each year. The conference presents the only opportunity for employees within Social Firms and Co-operatives, members, mental health and other professionals within the disability sector, and managers, to come together and learn/exchange views on social sensitisation issues, employment issues particular to people with mental health problems and other disabled people, organisation and management of Social Firms and Co-operatives, and Finance.

Social Firms / social cooperatives are market-led businesses set up specifically to create employment for people with mental health problems and other people with disabilities and disadvantages in the labour market. They will have at least 30% of their workforce who are disabled and or disadvantaged people and will generate at least 50% of their income through sales of products or services. Koi.S.P.E – the Greek Social Cooperatives

The Greek state, chose, as an overall public policy in the frame of the Greek Psychiatric Reform that started to take place during the 80's , the growth of social cooperatives of limited responsibility for the socio-economic and professional integration of individuals with psychosocial problems.

Social Cooperatives of Limited Liability (abbreviation: Koi.S.P.E) is a structure of social cooperatives in the field of entrepreneurship actions for people with mental health problems formulated under the Greek law 2716/99 of the Ministry of Health Care.

- They are Private Legal Entities, with limited responsibility for their members.
- They are aiming to the socio-economic inclusion and professional integration of individuals with psychosocial problems, contributing to their rehabilitation and economic self-sufficiency.
- They are Units of Mental Health, the growth and the monitoring of which belong to the Ministry of Health Care and are directed by the Department of Mental Health of the Ministry.
- They have commercial status.
- They are able to develop any economic activity (i.e. agriculture, industrial, craft-based, touristic, commercial, etc).

aims of the conference

For the past 26 years the Annual Conference of Social Firms Europe CEFEC is being organized once in a year in a different European city for exchange of views and practices on social issues, promotion of community awareness and employment for disabled and disadvantaged people.

After a period of ten years Greece is organizing its fourth Annual Conference of Social Firms Europe CEFEC.

This is an excellent opportunity for the international and national community, academics, social economy researchers, market and industry analysts, government officials, policy makers and entrepreneurs to:

- discuss and debate on the topic of social entrepreneurship during the present times
- to explore the possibilities and challenges that arise today in this field.

why in Corfu

A big psychiatric asylum was based for more than a century on the island and closed down a few years ago.

It was replaced by a well established community mental health network.

In parallel, Corfu (Kerkyra) is the home of **"New Horizons"** the most developed and awarded Social cooperative (Koi.S.P.E.) in Greece, with 100 employees and approx. 1 million euros turnover/ year.

The Kerkyra Koi.S.P.E. gained legal status in 2005 based on Law 2716/99 and acts both as a business as well as a mental health Unit.

SOCIAL ECONOMY is a concept with a wide range of interpretation. A section of economy that flirts with both private and the public sector. Pointing out and highlighting the main characteristics of this sector is important in order to make it recognizable and comprehensible and subsequently to explore and unfold the possibilities and opportunities that this sector could offer to society with the aim to implement and develop a social attitude of economy.

The experience of those involved in the fields of Social Economy could be used as a guide to those to follow.

What makes an enterprise a social enterprise, how society benefits, are there limits, are only some of the concerns that emerge and highlights the necessity of guidance, of a Social Enterprise Compass.

This plenary session gives the opportunity to an open discussion, a share of "know how" and exchange of thoughts on the significance of Social Economy in present times.

Entrepreneurial ideas from SETreality: in and out social economy

In the frames of the Conference program the Greek partner (KoiSPE Diadromes) of the European program "SETreality project" is organizing a plenary session under the title of: "Entrepreneurial ideas from SETreality: in and out social economy" where we wish to be presented the Italian and the Greek social cooperatives as a distinguished model of social and work integration of people with mental health problems and other types of disability and disadvantage as well.

In addition there will be a second part where other models of cooperatives and local enterprises will be presented as an effort to the research, exchange of ideas and know how among different types of enterprises.

Study Visits and City Tour

Walking guided city tour while visiting the Entrepreneurial activities of KoiSPE New Horizons

- **'Melissa'**
is a training and vocational rehabilitation centre of people with disabilities. Operates with the support of the Association of Creative Occupation of People with Special Needs "Melissa".
- **Bakery – pastry**
The bakery workshop is situated in Corfu Town. Bagels, bread, finger food and pastries are produced there and sold in the store on a daily basis. The bakery also supplies KoiSPE's activities, the student restaurant, the solidarity network and individual clients.
- **Catering service**
Catering Services are offered to private and public organizations, coffee breaks, welcome drinks, christening parties. Conferences are organized by the crew, in the place chosen by the client. Catering services supply food, meals, pastries, beverages drinks. Extra services such as decoration and music selection are available to satisfy even the most demanding clients.
- **Café Lunatico**
Lunatico Café is situated in the center of Corfu Town. It is very popular among university students and teachers. It serves finger food, coffees and drinks. There is free wi- fi and cable TV. Music and theatrical shows are often set in the area.
- **Town Hall Cafe**
Town Hall Café is set inside the town hall building. Its very popular among employees but also simple citizens. It serves finger food, coffee and pastries that are produced at KoiSPE's bakery.
- **Parking services**
In the center of Corfu Town, behind the Psychiatric Hospital, there is a 900 square meters parking area, that can accommodate up to 50 cars. Short and long term parking services are provided on a daily basis. The area is fenced, well- lit and fire safe.
- **Environmental park**
KoiSPE initiated the development of an environmental park to cultivate, produce and distribute organic products. The business plan provides the cultivation of citrus trees as well as running two greenhouses. In parallel, KoiSPE is planning to develop a small laboratory standardization products (oil, kumquat, etc.). It also plan to operate a selling point in the street market in the center of Corfu Town. Finally, in collaboration with primary and secondary education will be implemented training sessions for students on issues related to the development of alternative organic crops.
