225 have been the participants during the conference, 159 from Italy and 66 coming from 18 different countries.

***Aims and contents***

The conference took place in Trieste, well known for Dr. Franco Basaglia's historic revolution in the field of mental health, based on knocking down walls and restraints to be replaced by paths of inclusion and democracy in the light of sustainability and social economy. Just starting from his theories and experience in the field of mental health, in 1972 the first social cooperative called "CLU Franco Basaglia" was born for the inclusion of fragile individuals.

At a time when employment is increasingly difficult for individuals who are at a significant distance from the labour market because of their disability, their mental health problems or other forms of disadvantage, as being migrant or refugee, it is essential to



create jobs for such groups and one efficient and ethical solution is to facilitate the start-up and implementation of Social Enterprises that offer real, paid, sustainable employment options within a supportive working environment.

The Conference focused on the latest trends of the European social economy, with a particular attention on both the innovation potential of social enterprises in the ever changing political, economic and social environment and on the innovation strategies in social and health services, with a view to identifying new forms of reconciliation between the needs of the individual versus those of the free market. Every year Social Firms Europe CEFEC organizes a meeting to exchange and compare “best social practices” on new topics of discussion. Based on the assumption that new needs always require new answers and new synergies, CEFEC annual meeting main aim is to develop joint contributions and make them usable and transferable to different contexts.

The initiative took place over two consecutive days of frontal interventions, workshops, comparisons and exchanges, social events and awards.

**3 Visit to the cultural park of San Giovanni (ex mental Health Hospital)**

Participants could take part at a guided walk, lasting about an hour and a half, through what is now a beautiful flower garden, on the edge of the city of Trieste, crossed and experienced by many people for leisure, curiosity, relaxation, university studies, work in the health and social field, etc. But, until the mid-70s of the last century, it was a Provincial Psychiatric Hospital, an Asylum where people were segregated because of their mental (real or presumed) illness. San Giovanni, above all thanks to the commitment of dr. Franco Rotelli and his collaborators, is one of the few examples in Italy and in Europe of virtuous recovery and reuse of such a tragic place, in favor of the community.

**4 Visit to social enterprises in the city of Trieste: Trieste La Bora, Consorzio Ausonia**

In alternative participants could choose the visit of these two realities:

**AUSONIA.** Trip to the sea, in the urban context of Trieste, to visit a historic bathing establishment, important for the tradition of summertime in the city. A place that, after a past of great popularity between the 50s and the 90s, was in a state of complete abandonment at the beginning of the new century. It was in fact, social cooperation that in 2005 restored the establishment to the citizens, through the constitution of the AUSONIA Consortium, which counts today 9 local social cooperatives.

**TRIESTE LABORA.** Showroom and shop in the historic center of Trieste, collects and sells objects, works, projects and ideas of different artisan laboratories in favor of disadvantaged people, by the Social Services of the Municipality of Trieste and the associations and cooperatives that work and collaborate to the project.
